Call to Order

John Cunningham called the scheduled regular Spring Meeting of the Council of Governors (COG) to order, Friday, April 25, 2025, at 9:00 a.m. local time. A quorum was established.

Minutes of the COG 2024 Fall Meeting

Motion: Motion by Greg Palmer to accept the minutes of the 2024 Fall Meeting. Motion seconded. Motion carried.

Review of Agenda

John Cunningham reviewed the agenda. No changes or additions were made.

Financial Report

Eldonna Sadler reviewed the financial report for Fiscal Year 2025 as of February 28:

- The contingency fund balance stands at \$250,000.
- The carryover cash balance from Fiscal Year 2024 to Fiscal Year 2025 is \$222,089.15.
- As of the end of February, FY2025 revenue totals \$284,358.00, with expenditures of \$286,433.79, resulting in a cash balance of \$220,013.36.
- Revenue is expected to increase as payments on outstanding invoices are collected and new invoices are issued for site visits, administrative reviews, spring conference registration fees, and DOD payments.
- Expenditures include employee payroll and benefits, communications, building-related expenses, general business operations (mailing, equipment, printing, etc.), IFSAC meetings, Correlation Task Group workshop, COG workshop, NAFTD conference, FDIC, NFPA meeting participation, and site visit travel costs.
- The proposed FY2026 budget includes projected revenue of \$431,505.00 and projected operational expenses of \$429,914.50.
- Increases in payroll and benefits reflect the reclassification of one coordinator position, 25% salary of an IT specialist, and the planned hiring of an administrative support staff member.

Motion: Motion by Tara Youngblood to accept the Financial Report. Motion seconded. Motion carried.

Committee Reports

Logistics Coordination Committee

Bill Slosson reported for the Logistics Coordination Committee:

- The Committee convened on the afternoon of April 24 and had no action items; however, there was discussion prompted by the Travel Task Group regarding potential future meeting locations. Priorities are to either keep costs at or near GSA rates for lodging while maintaining a target rate of around \$150 per night for rooms some locations have GSA lodging rates that are considerably higher.
- The Travel Task Group has also been tasked with researching other accrediting bodies across North America to review their fee structures, billing practices, and related costs for comparison and future planning.

Operations Coordination Committee

David Jolly reported for the Operations Coordination Committee.

- The Committee convened on the afternoon of April 24.
- The Training Task Group will begin meeting monthly to coordinate training sessions for upcoming meetings and will work in collaboration with the Certificate Assembly Planning Committee.
- The Mentoring Task Group is actively developing a formal policy and mentoring program.
- The Operations Coordination Committee plans to meet every other month to ensure continued progress and alignment with objectives.

Planning Coordination Committee

Tara Youngblood reported for the Planning Coordination Committee:

- The Committee convened the morning of April 24. The group reviewed Agenda Memo D for potential conflicts; no concerns were identified.
- The Committee discussed the need to develop formal policies for the appeals process and the mentoring program and created task groups to work on each.
- The Ethics Task Group is working on consolidating the Investigative Guide and the Code of Conduct into a single document. Monthly meetings will continue to support this effort.

Future Meetings (Scheduled Regular Semi-Annual)

Eldonna Sadler reported on future meetings:

- Fall 2025 Meeting: Requests for proposals were sent to multiple hotels in the Nashville area; however, responses were limited, and pricing was high. As a result, alternative locations such as Oklahoma City, Oklahoma, and Lexington, Kentucky are now under consideration. Tentative dates are being targeted for the last two weeks of October, subject to hotel availability. A formal notification will be sent once a hotel contract is secured.
- 2026 Meeting Locations: The Travel Task Group will begin discussions to determine potential locations.
- Hosting a Future Meeting: Members interested in hosting an IFSAC meeting are encouraged to complete the host location application, available on the IFSAC website. Please ensure all required information is included in your submission to IFSAC Administration.

Proposed Fee Structure Amendments

John Cunningham asked if there were any concerns or feedback from the Degree Assembly regarding the proposed fee structure; none were conveyed. While the Certificate Assembly had no objections to the fee structure itself, they did express concerns about the proposed reduction in meeting frequency. It was suggested that approval for the new fee structure could proceed, including the format for covering hotel and registration fees for meetings, while postponing any decisions on meeting frequency until after polling the membership.

Motion: Rob Freese moved to adopt the new fee schedule, effective July 2026, which includes coverage of hotel and registration fees for one representative starting in 2027. Motion seconded. Motion carried.

IFSAC Administration will poll the membership regarding meeting frequency, with results to be reviewed before the Fall Meeting. Further action or announcements will be based on the outcome of that poll.
