Committee on Site Teams

Matt Thorpe reported for the Committee on Site Teams:

- The Committee discussed site team visit structure, including discretion of the site visit team leader and the entity. This will be discussed more on upcoming conference calls of the Committee.
- Discussion was held on on-site administrative reviews. This was tabled until the next conference call.
- The Committee is planning to work with the Training Committee to develop online site team member training.

- The Egyptian Navy was approved for a one-year extension from August 2022 to August 2023.
- Alberta was approved for a six-month extension from September 2022 through April 2023.

Site Visit Reports (Agenda Memo D)

Florida Bureau of Fire Standards and Training

Matt Thorpe reported on the site visit for Florida State Fire Marshal conducted November 2-4, 2021. Matt Thorpe served as a site visit team leader. Michael Lowe and Rodney Foster served as site visit team members. There were 27 items that needed to be addressed. All except for one have been fixed and Matt is looking for direction from the Board regarding management of test banks by a third-party. The site visit team recommended conditional reaccreditation. Discussion held.

Indiana Board of Firefighting Personnel Standards and Education

Gary Howard reported on the reaccreditation site visit for the Indiana Board of Firefighting Personnel Standards and Education. The site visit was conducted July 26 - 28, 2022. John Cunningham served as site visit team leader. Gary Howard and Matthew Palmerton served as site visit team members. The site visit team recommended accreditation/reaccreditation for Indiana Board of Firefighting Personnel Standards and Education for 18 levels.

Nova Scotia Fire Service Professional Qualifications Board

Dirk Moller reported on the reaccreditation site visit for the Nova Scotia Fire Service Professional Qualifications Board. The site visit was conducted June 14 – 16, 2022. Dirk Moller served as site visit team leader. Tara Youngblood and Gary Howard served as site visit team members. The site visit team recommended accreditation/reaccreditation of Nova Scotia Fire Service Professional Qualifications Board for 29 levels.

Tennessee Commission on Firefighting Personnel Standards and Education

The site visit team recommended accreditation/reaccreditation for Tennessee Commission on Firefighting Personnel Standards and Education for 31 levels.

New Brunswick Office of the Fire Marshal, Justice and Public Safety

Kim Davis reported on the reaccreditation site visit for the New Brunswick Office of the Fire Marshal, Justice and Public Safety. The site was conducted June 21 - 23, 2022. Bernie MacKinnon served as site visit team leader. Site visit team members were Kim Davis and Janine Aussem. The site visit team recommended accreditation/reaccreditation for New Brunswick Office of the Fire Marshal, Justice and Public Safety for 8 levels.

Oklahoma State University Fire Service Training

Bill Slosson reported on the reaccreditation site visit for Oklahoma State University Fire Service Training. The site visit team recommended accreditation/reaccreditation for Oklahoma State University Fire Service Training for 20 levels.

Emerging Trends in the Fire Service

NFPA 1010

Bill Slosson explains NFPA is consolidating emergency responder documents and what is occurring with NFPA 1010 specifically. NFPA 1010 will be the compilation document of 1001, 1002, 1003, and 1005. They have completed first draft. The first draft has been reviewed by the NFPA Correlating Committee and they are battling that right now. What training and testing entities need to know is for the first time the Fire Fighter I chapter has added a specific device to a required knowledge and skill element. The Technical Committee added a thermal imaging camera to the JPR – a specific call about a single piece of equipment. As of this moment, the tick is not on the standard list of equipment in NFPA 1901. Bill anticipates there will be challenges for small agencies to train and to test on a piece of equipment that some of them do not own and do not have access to until the state fire marshal comes to investigate their fire. Without recommendation, Bill offers for anyone needing to know how to submit public input when 1010 goes into second draft, to contact him, Matt Thorpe, or John Cunningham to guide you through the process. Bill comments on being aware of what is coming and participation in the input process.

472 and 1072 – Prerequisites for Fire Fighter

Discussion was held on Hazardous Materials prerequisites for Fire Fighter (Awareness, Operations, PPE, Product Control):

- Testing together and grading separately
- Testing separately
- Issuing separate certifications or showing each on one certificate
- When issuing reciprocity, entity needs to know which levels the candidate holds
