# 3.5 COUNCIL OF GOVERNORS

- **3.5.1** The Council shall consist of ten (10) voting and  $\frac{\text{two-three}}{\text{three}}$  (23) non-voting members:
- (A) Three (3) members elected from the Certificate Assembly.
- (B) Three (3) members elected from the Degree Assembly.
- (C) The public members from each assembly. See A.3.5.1 (C)
- (D) The chair of each assembly shall be a voting member of the Council. See A.3.5.1 (D)
- (E) One (1) member of Administration shall serve as a non-voting member.
- (F) The parliamentarian and assistant parliamentarian of the Congress shall serve as a non-voting members.
- (G) Council members from the assemblies shall serve staggered three (3) year terms.

- (H) Election of Council members to fill seats vacated by members having served a three (3) year term, with the exception of each assembly chair and public member, shall occur during the spring meeting.

- (J) To ensure representation on the Council remains balanced and uniform, no more than one entity representative shall serve on the Council at any given time. See <u>A.3.5.1 (J)</u>

#### ARTICLE 21 BYLAWS OF THE DEGREE ASSEMBLY

# **21.9 ACCREDITATION**

- 21.9.1 The accreditation process will be administered based on the Bylaws, policies, procedures, and criteria of the Assembly.
- (A) Accredited programs must continue to meet the Criteria for Accreditation once accredited. Failure to meet accreditation criteria shall result in withdrawal of accreditation.
- (B) Accredited entities shall complete and submit an Annual Status Report each year per the Annual Status Report Procedures.
- (1) In the event of national emergencies within our member countries, delays in submitting the program's Annual Status Report shall be considered on a case-by-case basis. These emergencies can include natural and man-made disasters, pandemics, interruptions to critical infrastructure, et al.

# G23.2.4 POLICIES AND PROCEDURES DOCUMENTATION

- (a) Each program shall have access to the institution's policy and procedures.
- (b) Each program shall have access to the faculty/staff handbook. If a faculty/staff handbook is not used by the institution, an alternative method of providing this information shall be identified.
- (c) The policies and procedures of the program shall be compatible with the philosophy and goals of the institution.
- (d) The program shall have a policy in place protecting students, faculty, and staff from harassment and discrimination
- (e) The program shall develop and maintain policies and procedures for the revocation and denial of degrees
- (f) The program shall have an appeals process. Programs shall document procedures to resolve disputes arising from the interpretation or application of any provisions of the degree-granting process.
- (g) The program shall provide evidence of compliance with applicable statues and other local, state/provincial/territorial, and federal regulations operative in its jurisdiction (e.g. such as those issued by the Occupational Safety and Health Administration (OSHA), the Environmental Protection Agency (EPA), and the Family Educational Right to Privacy Act (FERPA).)

- (a) The program shall have a sufficient number of faculty to implement program objectives.
- (b) Faculty duties and responsibilities shall be defined.

- (d) Faculty workload shall be defined including program administration duties, online instructional load, and other duties as assigned.
- (e) Faculty training, education, and expertise shall be appropriate to assure high quality learning experiences in all phases of the program.
- (f) There shall be opportunities for program faculty to be represented on institutional committees, as well as those in the program.
- (g) Faculty should be formally represented on all committees, groups, or organizations concerned with the development, implementation, evaluation, and revision of program curriculum.
- (h) Faculty shall meet the regional accrediting agency's requirements for all courses that they are assigned to teach for institutions located in the United States and its territories. Or for institutions not located in the United States and its territories, Faculty shall meet the requirements of the regional or institutional organization of said country or by state sanction of said country.
- (i) Faculty shall meet the requirements of the regional or institutional organization of said country or by state sanction of said country, for institutions not located in the United States and its territories.

# **G23.3.4.4 Instructional Equipment, Supplies, and Materials** (N/A for 100% online programs)

- (a) Adequate equipment and supplies shall be available to the program to effectively achieve educational goals.
- (b) There should be adequate space available for storage of equipment, supplies, and materials.
- (c) The program administrator should periodically assess the instructional equipment, supplies, and materials and make recommendations for modification or replacement of instructional equipment, supplies, and materials.
- (d) There should be adequate provision for updating equipment in response to changing practices in technology.
- (e) Sufficient expendable materials should be available to accomplish learning outcomes defined in program documents.
- (f) Personal protective clothing, apparatus, equipment, and facilities used in the instruction/evaluation of candidates shall meet the applicable NFPA standard(s) adopted by the authority having jurisdiction

#### CABOG: 10.5.1 (A)(1) & (A)(2)

(1) A member's entity shall be an accredited voting member before the member is eligible for election to the Board or be appointed by the chairperson of the Board. (2) To ensure representation on the Board remains balanced and uniform, no more than one entity representative shall serve on the Board at any given time.

## CABOG Chair: 10.5.8

The chairperson and the vice-chairperson of the Board shall be elected from the sitting Board members. The public board member is not eligible to be elected as chairperson or vice-chairperson.

## DABOG: 20.5.1 (A)(1) & (A)(2)

(1) A member's entity shall be an accredited voting member before the member is eligible for election to the Board or be appointed by the chairperson of the Board. (2) To ensure representation on the Board remains balanced and uniform, no more than one entity representative shall serve on the Board at any given time.

#### COG: 3.5.1 (I) & (J)

(I) A member's entity shall be an accredited voting member before the member is eligible for election to the Council or be appointed by the chairperson of the Council. (J) To ensure representation on the Council remains balanced and uniform, no more than one entity representative shall serve on the Council at any given time.
